

## 2025 - 2026 Schedule of Dues

### CHARTERED/PROVISIONAL CHAPTERS:

Associate Member Dues.....	\$125 per AM
Initiation Dues.....	\$250 per Initiate
Fall Membership Dues.....	\$90 per Member (billed October 15)
Fall Housing Initiative.....	\$15 per Member (billed October 15)
Spring Membership Dues.....	\$95 per Member (billed February 15)
Spring Housing Initiative.....	\$15 per Member (billed February 15)
International Convention Assessment.....	\$1,200 per chapter (billed January 15)
Regional Leadership Academy Assessment....	\$1,500 per chapter (billed on or before January 15)

### RISK MANAGEMENT ASSESSMENT

Each chapter's Risk Management Assessment (RMA) is based on the information they provide in the RMA calculator, and the chapter's roster as of June 30 each year. Billing is as follows:

Semester Schools.....	Fall 2025: 60% will be billed on September 15 Spring 2026: 40% will be billed on February 15
Quarter Schools.....	Fall 2025: 60% will be billed on October 1 Spring 2026: 40% will be billed on February 15

*Note: An additional RMA charge will be assessed each spring for all fall initiates, equalling 50% of the base rate per fall initiate*

### PROVISIONAL CHAPTER EXCEPTIONS

No Associate Member Dues are paid by those initiated as part of the first initiation ("Founding Fathers"), as determined by the Executive Director & CEO.

No provisional chapter shall be charged either an International Convention Assessment or Membership Dues from its inception until one year following the date of the first initiation of members. From that date until two years following the first initiation, the provisional chapter shall be billed at the rate of 50% of a chapter, rounded to the nearest whole dollar. Starting on the date two years following the first initiation, the provisional chapter shall be billed at the rate of 100% of a chapter.

Regional Leadership Academy Assessment....	Determined by Board of Regents each year, billed on or before January 15

### RISK MANAGEMENT ASSESSMENT

Each chapter's Risk Management Assessment (RMA) is based on the information they provide in the RMA calculator, and the chapter's roster as of June 30 each year. Billing is as follows:

Semester Schools.....	Fall 2025: 60% will be billed on September 15 Spring 2026: 40% will be billed on February 15
Quarter Schools.....	Fall 2025: 60% will be billed on October 1 Spring 2026: 40% will be billed on February 15

*Note: An additional RMA charge will be assessed each spring for all fall initiates, equalling 50% of the base rate per fall initiate*
