

## 2025-2026 Chapter Finance Guide

It is always important for every Delta Chi chapter to consider how to better prepare for the future. Financially, it is the responsibility of our members to manage their chapter finances to support their members during hardship, meet their International Fraternity financial commitments, and allow the brotherhood experience to continue, even during or despite unforeseen circumstances. This guide is meant to support chapter “D”s, executive boards, and Advisor Board of Trustees (ABT) to financially manage the upcoming academic year and beyond.

### MEMBERSHIP AND LOCAL DUES

Just as recruitment and brotherhood drive the legacy of Delta Chi, so do your membership and local chapter dues. Finances are part of the Delta Chi experience to ensure your chapter and your future brothers will have the same opportunities. Meeting the financial obligations of membership and creating a positive experience for all brothers is essential to the long lasting bond of Fraternity.

### FRATERNITY MEMBERSHIP DUES/FEEs

The total average amounts owed for the 2025-2026 academic year to the International Fraternity for Initiated Members and all Associate Members are listed below. These cover member dues, housing initiatives, insurance through the Risk Management Assessment (RMA), and initiations. Not included are the chapter assessment fees for the International Convention and Regional Leadership Academy, billed per chapter each January.

## LOCAL CHAPTER DUES

Local Delta Chi chapter dues should be adjusted and considered in the budgeting process to prepare for the current and upcoming academic years. The chapter is responsible for all bills and remaining current with International accounts. Additionally, chapters should consider additional expenses that are campus specific like billing agency fees, a Fraternity and Sorority Life administration fee, or an Interfraternity Council (IFC) fee. Every campus is different and each chapter is responsible for upholding all financial obligations for successful operations.

## HOUSING/FACILITIES

Local Delta Chi house corporations are responsible to manage and support the expenses of all housing and facility operations. This includes rent, utilities, meal expenses, etc. All questions on housing/facility fees should be directed to your local house corporation boards or the Barrister Capital Corporation.
