THE ASSOCIATE MEMBER CEREMONY WILL BE CONSIDERED "DAY ONE," AND THE INITIATION CEREMONY MUST OCCUR ON OR BEFORE CALENDAR DAY 35. IT IS RECOMMENDED THAT THERE BE NO MORE THAN FIVE CALENDAR DAYS BETWEEN BID ACCEPTANCE AND THE ASSOCIATE MEMBER CEREMONY.
